Personal data which we process

HomeShow B.V. processes your personal data because you use our services and/or because you provide these to us yourself.

Special and/or sensitive personal data that we process

Our website and/or service does not intend to collect data about website visitors under the age of 16. Unless they have permission from their parents or guardian. For what purpose and on what basis we process personal data

How long we retain personal data

Sharing of personal data with third parties

We enter into a data processing agreement with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. HomeShow B.V. remains responsible for these processes. With companies whose data we process on behalf of this entity, we conclude a processor agreement to ensure the same level of security and confidentiality of your data.

Cookies, or similar techniques, that we use

HomeShow B.V. uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. HomeShow B.V. uses cookies with purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered. These cookies are also used to make the website work properly and to optimize it. In addition, we place cookies that track your browsing behaviour so that we can offer customized content.
